Compliance Status

This website is **partially compliant** with <u>Web Content Accessibility</u> Guidelines 2.1 level AA.

Accessibility Features of this Website

Adjust font size – increase font size.

Change Contrast – adjust website to high contrast.

Correctly structured content with good heading usage – to increase readability and assist users using screen readers or other assistive technologies.

Cross operating system compatibility and mobile navigation – to ensure consistency in layout and navigation across all devices and operating systems.



Skip to content link – enabling users to quickly access the core content of a page without having to cycle through numerous navigation menus or headers.

Focus Outlines – a visual indicator like a border or outline around interactive elements (like a button, link or input field) when it is focused on using the keyboard.

GSpeech - this allows users to highlight text and have it read aloud.

Non-accessible Content

Images – we are currently working through images to add contextual alternative text.

Tables – we are working to create correctly labelled and accessible tables.

Videos – we are working to add captions and text transcripts to videos.

Document accessibility has not yet been implemented.

Third-party content – there are areas of our website controlled by third-party companies, such as cookie settings and the accessibility tools. These are not funded by, developed, or controlled by Clare Sports Partnership, but work is in progress to resolve as many issues related to these areas as feasibly possible.

Preparation of this Accessibility Statement
